#1E-2023-0606: RESOLUTION REQUESTING PRIORITIZATION OF THREE TSI REQUESTS IN ANC 1E

Dear Christine Mayeur,

ANC 1E requests that your team prioritizes the following TSI requests in the upcoming July selection:

- SR 23-00331084: Requesting raised crosswalk at the intersection of Euclid Ave NW and 9th Street NW
- SR 23- 00331124: Requesting crosswalk markings at the northern intersection of Georgia Avenue NW and Euclid Ave NW
- SR 23- 00331102: Requesting “daylighting” of crosswalk at the intersection of Euclid Ave NW and 9th Street NW

All of these requests are either along or near Georgia Avenue NW, a high injury network corridor as designated by the [Vision Zero 2022 Update](#). Additionally, all are near Banneker Recreation Center and the current site of School without Walls – Francis Stevens.

We previously asked in “#1E-2023-0304: Letter Supporting Adjusting the PUDO Zone and Additional Safety Improvement Near School Without Walls At Francis-Stevens” for both the raised crosswalk and the daylighting of the crosswalk. We were told we needed to submit separate TSI for these requests, which is why we are now sending this letter.

ANC 1E designates Commissioner Josh Jacobson to represent the Commission in all matters relating to this letter. In the event the designated representative Commissioner cannot carry out their representative duties for any reason, ANC 1E authorizes the Chair to designate another Commissioner to represent the Commission in all matter relating to this Resolution.
